ROYAL RESOURCES TO FUND ALDERSHOT FOR \$1,500,000

Further to Aldershot Resources Ltd's ("Aldershot" and the "Company") news release dated March 7, 2011 in which was disclosed the execution of a Share Exchange Agreement between Royal Resources Ltd. (ASX: ROY) ("Royal Resources") of Perth Western Australia, its wholly-owned Colorado subsidiary, Royal USA Inc. ("Royal USA") and Aldershot pursuant to which the Company agreed to acquire all of the shares of Royal USA in consideration of the issuance of 35,000,000 shares.

Royal Resources had the option to provide initial funding for exploration either by a two year convertible loan in the amount of \$1,500,000 or by a private placement of \$1,500,000, at \$0.05 per unit. Each unit will be comprised of one common share and one non-transferable warrant. Each warrant will be exercisable for a period of two years, at a price of \$0.10 per share. The Company undertook to disclose which method of financing will be proceeded with.

Jeremy Caddy, president and CEO of Aldershot, is pleased to announce that Royal Resources has agreed to subscribe to a non-brokered private placement of 30,000,000 Units in the capital of the Company at a price of \$0.05 per Unit. Each Unit will be comprised of one common share and one share purchase warrant exercisable for a period of two years at price of \$0.10 per share.

The terms of the proposed acquisition of shares of Royal USA and issuance of Aldershot shares and warrants are subject to shareholder and TSX Venture Exchange approval. The terms of the proposed financing are subject to TSX Venture Exchange approval.
