#### The Role:

As the Manager, Financial Reporting, reporting to the VP Finance & CFO, the role will expand beyond financial reporting to include key commercial aspects for the business across multiple provinces. The Finance team is small and growing and the ideal candidate will be part of shaping the future of both the function and business.

We are a close-knit, dynamic team working towards common objectives in a vibrant and high-energy environment. The ideal candidate will be a strong team player who can collaborate effectively within a group while also making meaningful individual contributions as the situation requires.

# Key responsibilities include:
